Beverage Selection:

BYO wine and beer is available at Omori Estate Vineyard, at a small corkage charge. An on license will be provided. Bar staff are not included in the package, however can be provided at an additional cost.

Omori Estate Vineyard - Terms & Conditions

The following general information and terms and conditions apply to all functions held at Omori Estate Vineyard. We are happy to answer any queries you may have regarding this information.

Confirmation:

Confirmation of a booking is required in writing or email together with a deposit of \$3000 (or as specified by your event organiser). The receipt of confirmation and deposit shall constitute a binding contract between Omori Estate and yourself. A completed copy of these Terms & Conditions need to be signed to by both parties. Provisional bookings will be held for one 14 days.

Cancellation:

Cancellation must be advised in writing. In the event that an function has to be cancelled, the following conditions apply:

- 1. For functions cancelled 6 months or more prior to the scheduled event 50% of the deposit will be refunded.
- 2. For functions cancelled within 6 months prior to the function, the deposit will not be refunded.
- 3. If cancellation occurs within 14 days of the function's scheduled start, the full deposit will not be refunded and the client shall be liable for payment of the full value of the catering and package costs.

Guaranteed Numbers:

Confirmation of numbers attending your function must be given seven working days prior to the reserved date. Charges will be based on the number of people attending the function, or the guaranteed number whichever is the greater.

Beverage:

BYO wine and beer is available at Omori Estate Vineyard, with a \$5.00 per person corkage charge. Bar staff are supplied as part of the package.

Hours:

The package costs cover access for eight hours, with an additional \$150.00 to be charged per hour should the event run any longer. Last drinks will be called at the bar at 12:30am with all guests to have vacated the premises no later than 1:30am

Music:

We welcome all forms of entertainment, but for the consideration of our neighbors music must cease at 12.00am.

Venue Access:

Access to the venue for breakdown and set up will be dependent on other events. Rehearsals are welcomed, and times will be by mutual agreement.

Confetti:

No confetti is allowed on Omori Estate grounds. Only fresh petals may be thrown.

Fireworks:

Due to our rural surroundings, fireworks are not permitted.

Menu Selection

The menu shown within is only a sample menu, and does change seasonally. Please ensure that you have current menus before making your selections. Please confirm your menu selection at least 30 days prior to the event, or as otherwise advised.

Damage/Insurance

Any equipment/items brought in by the client either rented or owned is their responsibility, whether hireage is arranged by the client or the vineyard. Omori Estate will not accept any responsibility for damage or loss of equipment or merchandise left on the premises prior to, during or after the function, but will take every care. Organizers are financially responsible for any damage sustained to property during functions, by the organizer or any of their guests, invitees or other persons (e.g. contractors). *PLEASE NOTE - The deposit paid by you will act as a bond to any damage caused.

Compliance

The client must conduct their function in an orderly manner, in full compliance with these terms and conditions, and with all applicable laws. It is your responsibility to ensure that all attendees behave in an orderly manner during the event. It is agreed that guests comply with all reasonable requests where necessary from Omori F state personnel. Omori F state reserves the right to exclude or

eject any objectionable persons from the premises without any liability in accordance with our Liquor Licence.

Force Majeur

Where matters beyond reasonable control, impair or prevent Omori Estate Vineyard from being able to perform it's obligation, the client releases Omori Estate from any liability or loss, incidental or consequential to such matters.

Payment Terms

A \$3000.00 deposit is required upon signing the contract, and acts as confirmation. 50% of the remaining balance is due 3 months prior, with final payment due 7 days prior to the Wedding date. We accept cheque, credit card or direct deposit as your form of payment for the event. Payment by credit card will incur a 2.5% surcharge. All prices are quoted inclusive of GST All accounts are to be fully prepaid Any additional charges incurred must be paid prior to departure by cash or credit card, which will include any charges not authorized in the original contract, known to the organiser. Omori Estate Vineyard has the authority to charge your credit card for any outstanding amounts associated with your function (you will be advised prior to this). Omori Estate does not accept payment by Diners or Amex.
